## **T2202 – Tuition and Enrolment Certificate**

### What is T2202?

T2202 – Tuition and Enrolment Certificate, is the tuition tax receipt issued to all students who paid tuition for courses in the previous calendar year (January to December).

### Are you eligible to obtain T2202?

### Canada Revenue Agency requires the college to provide a T2202 to all students who:

- are 16 years or older,
- was enrolled during the calendar year (January to December) in a **qualifying educational program or a specified educational program at a post-secondary institution**,
- has paid at least \$100 for tuition fees for courses taken in respect of the calendar year (January to December).
  - Note that fees such as student fees and accommodation fees are not eligible for tax deduction.

### When are T2202s available?

- T2202 for 2022 tax year will be available on February 20, 2023.
- If you are eligible to obtain a T2202, you can view and print your T2202 through the Student Self-Service.
- Please note that in addition to 2022 tax year, T2202 for 2021 tax year are also now available through the Student Self-Service.

### Your Social Insurance Number (SIN)

# Canada Revenue Agency requires that you provide your Social Insurance Number (SIN) so that it can be recorded on your T2202.

- You will need to ensure that your Social Insurance Number is provided to the college. To confirm that the college has your SIN;
  - 1. Login to Student Self-Service
  - 2. Select Profile Tile and view your Personal Details
- To correct your SIN, contact the Registrar's office by email at <u>nunatta@arcticcollege.ca</u>
- If there is no SIN provided to the college, this field on your T2202 will display 999-999-999.
- If you file a tax return without your SIN, CRA may subject you to a penalty of \$100.

### **Changes to your T2202**

- Nunavut Arctic College is required to submit student T2202 information to the Canada Revenue Agency at the end of February. Any changes to T2202 information will be submitted to CRA on a monthly basis starting at the end of the following month.
- If you povide the college your SIN after February 20, 2023, you may ask to reprint your T2202 so that you can file your 2022 tax return. However, the CRA will not receive the updated information until the end of the following month.
- If payments towards tuition fees in prior year are made after February 20, 2023, the amount will be reported to CRA at the end of the following month.
- If additonal payments towards tuition fees in prior year are made after February 20, 2023, the revised amount will be reported to CRA at the end of the following month.

### How to download your T2202?

- 1. Login to Student Self-Service
- 2. On the homepage, click on the **T2202 Tax Receipt** tile.
- 3. Select the Tax Year in the drop-down list.
  - Your tax information is populated once a tax year is selected.
- 4. Click this button Create Printable T2202 (PDF) to view your T2202.
  - If your PDF does not appear after you click Create Printable T2202 (PDF), check your pop-up blocker settings and try again.
